RESOLUTION NO. 2026-04 (REVISED FROM 2025-02)

A resolution setting the cost(s) of a burial plot and associated fees in Wales Town Cemetery.

WHEREAS: Wales Town owns and operates a municipal cemetery, and

WHEREAS: Costs associated with managing and operating the municipal cemetery continue to increase, and

WHEREAS: Wales Town is continually making much needed improvements and upgrades to the cemetery, and

WHEREAS: The Wales Town Council sees the need for these improvements and continued accountability of the Town's municipal cemetery, and

WHEREAS: The Wales Town Council and other Town Officials desire to make the cemetery burial plots and fees as fair as possible, and

WHEREAS: The Wales Town Council has adopted an Ordinance governing its operation which provides, among other things, the right to change or fix cemetery fees by resolution.

NOW THEREFORE IT IS HEREBY RESOLVED BY THE MAYOR AND TOWN COUNCIL OF WALES TOWN, SANPETE COUNTY, UTAH, AS FOLLOWS:

SECTION 1. BURIAL PLOT(S) AND ASSOCIATED FEES.

Fees for burial plots, as well as charges for opening and closing of graves, are due at time of service. Charges that remain unpaid, without special arrangements made with the Wales Town Clerk, will be subject to collection after 45 days from the time of service.

Residency is determined at the time of purchase of the burial plot.

NOTE: Wales Town reserves the right to wave any of the cemetery fees at its discretion.

Residents – Those persons living within Wales Town limits.

Non-Residents – Those persons not qualified as a Resident.

Infant – age 0 to 12 months

SECTION 2. GRAVE SIZE. Burial grave size is 4 ft. wide x 8 ½ ft. in length, that may accommodate (1) one burial vault buried at a depth of 6ft. or (2) two cremation urns buried at a depth of 4ft.

SECTION 3. VAULT REQUIREMENTS. In accordance with the Cemetery Ordinance, cement burial vaults will be required for all burials in the Wales Town Cemetery.

SECTION 4. BURIAL CERTIFICATE REPLACEMENT. Before replacement of a Burial Certificate will be made, the Cemetery Superintendent will verify the availability of title and physical location. The replacement of a Burial Certificate will be made on proof of receipt and payment of replacement fee. If no proof of receipt can be made, a petition for replacement shall be made to the Town Council. Upon approval of the Town Council and receipt of the Replacement Fee, a replacement Burial Certificate will be issued.

SECTION 5. NOTE, ADOPTION AND APPROVAL.

A. **Be it noted, all previous resolutions or acts in conflict with this resolution, or any part thereof are hereby repealed to the extent of conflicts.**

B. Be it therefore noted, before any grave can be opened, the applicant must present proof of burial certificate or proof of payment establishing title.

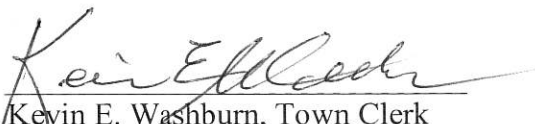
C. This resolution shall become effective on the 17th day of April 2026.
